# MINUTES of the XXIX Congress

# The International SAMBO Federation (FIAS) Hotel Bogatyr, Sochi, Russia on 9<sup>th</sup> November 2017

#### Speaker: Mr. V. Shestakov

Mr. V. Shestakov, President of FIAS welcomed the members present at the XXIX FIAS Congress and handed over the floor to Mr. S. Eliseev European Sambo Federation and All-Russian Sambo Federation President.

Mr. S. Eliseev welcomed the members present at the XXIX FIAS Congress on behalf of the host country.

Mr. V. Shestakov handed over the floor to Mr. R. Ferraris, FIAS Secretary General for leading the Congress.

#### II. Roll-call

#### Speaker: Mr. R. Ferraris

Mr. R. Ferraris informed the Congress that FIAS Executive Committee had elected a Congress Registration Commission, comprising of Mr. R. Akhmedjanov of Uzbekistan as the Chairman of the Commission with Ms. S. Ryazanova of Russia, Ms. V. Pavlycheva of Russia, Mr. A. Melikyan of Russia, Mr. J. Maldonado of Nicaragua, Ms. K. Moustaid of Morocco as Registration Commission Members, empowered to monitor and record the mandated rights of members participating in the said XXIX FIAS Congress.

- Mr. R. Akhmedjanov announced that the Registration Commission had diligently verified mandates presented and had duly registered all members eligible to participate in the XXIX FIAS Congress. He detailed that participants were present from 90 National SAMBO Federations and from five continents, including:
- 79 representatives of Member National SAMBO Federations who are full FIAS members, duly authorized to participate and vote in the Congress;
- 11 representatives of Candidate Members and invited National SAMBO Federations, duly authorized with the right to participate but without right to vote in the Congress.

15 out of 16 Members of the FIAS Executive Committee were present at the Congress.

Based on the above, Mr. R. Ferraris declared that quorum for decision-making was adequate and that the XXIX Congress of International SAMBO Federation was declared open.

## Speaker: Mr. R. Ferraris

Mr. Ferraris proposed a motion that a Ballot Scrutiny Commission shall be constituted to count and record the votes of the Congress Participants and informed members present that the FIAS Executive Committee had nominated Mr. S. Gopi (India), Mr. M. Borisov (Russia) and Mr. V. Zelonijs (Latvia) for the said Ballot Scrutiny Commission and requested the members present to vote and ratify the said nomination.

Ballot: 71 members voted for the Motion, Nil Against, Nil Abstained. Resolved that the Motion be adopted unanimously.

## IV. Approval of the Minutes of the FIAS Congress 2016

## Speaker: Mr. R. Ferraris

Mr. R. Ferraris proposed that the Minutes of FIAS XXVIII Congress held at Sofia (Bulgaria) on November 10, 2016 shall be ratified and approved and requested the members present to vote and ratify and approve the said Minutes.

Ballot: 72 members voted for the Motion, Nil against, Nil abstained. Resolved that the Motion be adopted unanimously.

Ballot: 70 Members Voted for the Motion, Nil against, 2 abstained Resolved that the Motion be adopted by the majority votes.

Ballot: 70 members voted for the Motion, Nil against, 1 abstained. Resolved that the Motion be adopted by the majority votes.

# VI. FIAS membership

# Speaker: Mr. S. Gopi

Mr. S. Gopi informed the Congress that in his capacity as the Chairman of the FIAS Legal Commission, he proposed to submit the following membership approvals to the FIAS Congress, after careful due diligence and legal verification of all membership documents as submitted by the parties concerned:

Italian Kickboxing, Muay Thai, Savate, SAMBO Federation (FIKBMS), Kazakhstan Sport and Combat SAMBO Federation, SAMBO and Associated Sports Association of San Jose (SAMBO and Associated Sports Association of Costa Rica), Uruguayan SAMBO and Combat SAMBO Association;

c) Granting of FIAS Candidate Membership to Hong Kong China SAMBO Association.

Accordingly, Mr. R. Ferraris proposed the motion that the Congress approve:

a) Exclusion from FIAS Membership of the following national SAMBO federations:

Sierra Leone SAMBO Federation, Portuguese SAMBO and Associated Disciplines Federation, Italian SAMBO Association, Republican Public Association SAMBO Federation of Republic of Kazakhstan,

b) Inclusion for FIAS Membership of the following national federations:

Italian Kickboxing, Muay Thai, Savate, SAMBO Federation (FIKBMS), Kazakhstan Sport and Combat SAMBO Federation, SAMBO and Associated Sports Association of San Jose (SAMBO and Associated Sports Association of Costa Rica), Uruguayan SAMBO and Combat SAMBO Association;

c) Granting of FIAS Candidate Membership to Hong Kong China SAMBO Association.

Ballot: 69 Members Voted for the Motion, 1 against, 1 abstained Resolved that the Motion be adopted by the majority votes.

# VII. FIAS President's report

# Speaker: Mr. V. Shestakov

Mr. V. Shestakov, FIAS President, spoke in length informing the members present of various aspects of SAMBO development on a global level and FIAS plans for upcoming 4 years.

Mr. R. Ferraris proposed the motion that the members present adopt the FIAS President's report.

Ballot: 77 Members Voted for the Motion, Nil against, Nil abstained Resolved that the Motion be adopted unanimously.

### Speaker: Mr. A. Klyamko

Mr. A. Klyamko gave a detailed report on the financial status of FIAS and then Mr. R. Ferraris proposed the motion that the Members present vote for FIAS Balance Sheet for 2017, FIAS Auditors Report, Provisional FIAS budget for 2018.

Ballot: 76 Members Voted for the Motion, Nil against, 2 abstained Resolved that the Motion be adopted by the majority votes.

## **IX. Report of the FIAS Commissions**

#### Speaker: Mr. R. Ferraris

Mr. Ferraris made a detailed report of FIAS Commissions work during 2017 and proposed the motion that the members vote to adopt the report of the FIAS Commissions.

Ballot: 76 Members Voted for the Motion, 1 against, 1 abstained Resolved that the Motion be adopted by the majority votes.

#### X. FIAS President's Elections

#### Speaker: Mr. R. Ferraris

Mr. R. Ferraris informed that only one candidature for FIAS presidency was received. The All-Russian Sambo Federation proposed Mr. V. Shestakov for his third term. It was noted that Mr. V. Shestakov complies with all requirements of FIAS Statute for FIAS Presidency.

Mr. R. Ferraris proposed the motion that the FIAS President's election shall be open ballot.

Ballot: 79 Members Voted for the Motion, Nil against, Nil abstained Resolved that the Motion be adopted unanimously.

Mr. R. Ferraris proposed the motion that Mr. V. Shestakov to be elected as the FIAS President for a four-year term.

Ballot: 79 Members Voted for the Motion, Nil against, Nil abstained Resolved that the Motion be adopted unanimously.

#### XI. FIAS Executive Committee members' elections

## Speaker: Mr. R. Ferraris

Mr. R. Ferraris informed that according to the FIAS Statute the number of the FIAS Executive Committee members is defined by the Congress and suggested to have 17 Executive Committee members for the next four years.

Ballot: 76 Members Voted for the Motion, Nil against, 2 abstained. Resolved that the Motion be adopted by the majority votes.

Mr. R. Ferraris informed the FIAS Congress about the requirements of FIAS Statute for FIAS Executive Committee members and stressed on the FIAS Statute's articles explaining legal status of continental presidents, the Chairman of FIAS Athletes' Commission and guarantees for woman candidatures.
